### Short Biography

---

Klaas Van Gelder (PhD) is a historian specialising in early modern political history and culture, with a special interest in the history of the Austrian Netherlands and the Habsburg Monarchy. His main research subjects include decision-making processes, political negotiations and lobbying, political and diplomatic culture, ritual and ceremony, and network analysis. His PhD (Ghent University, 2012, and awarded the Franz Stephan Prize 2014) analyses the establishment of the Austrian regime in the southern Netherlands following the War of Spanish Succession (1716–25). He was a postdoctoral researcher at Ghent University and University of Vienna and has taught several courses at the Universities of Ghent and Antwerp. His current research project, funded by Belspo (Belgian Science Policy) and carried out at the State Archives in Ghent, focuses on legislation in local lordships (*heerlijkheden/seigneuries*) in the County of Flanders.
